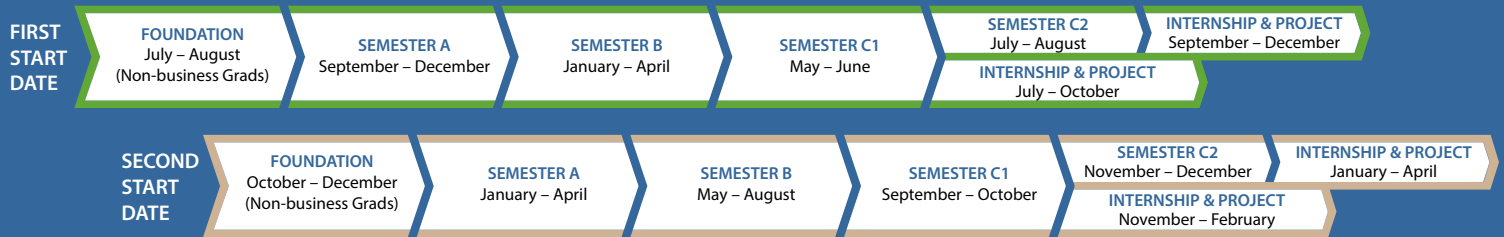

Structure

Vancouver Island University's MBA/MScIM Dual Degree program is offered in an intensive 14-16 month, full-time format which includes a 4-month Internship and Applied Business Project. Students without an undergraduate degree in business complete a 2-month Foundation Program before the start of the MBA/MScIM program. Students choosing the MBA only do not need to do the Applied Business Project.



Internship

Students complete an internship in the final 4 months of the program. Our MBA internship coordinators provide training and support to prepare students for the job market, for career success and connect students to internship opportunities.

Options and Applied Business Project

Each student can choose to take the Financial Services option, the Marketing option, or complete the General option. Students choosing the Financial Services and Marketing options take two additional courses (for a total of 4 in the option area) over a 7 week period in semester C2. Students who choose the General option start their internship and project after the completion of semester C1. Students who choose the MBA only option will do the Applied Business Project if they choose the general option, but not if they do the Finance or Marketing options.

Cost of Living

The average cost of living including housing, food, local bus transportation and medical insurance is \$800–1000 per month.

General Admission Requirements

- A minimum “B” average in the final 2 years of a business or non-business Bachelor’s degree
- Letter of intent, résumé, and 2 letters of reference from past employers or professors must be included as part of the application

A minimum of one year of work experience.

GMAT and Graduate Record Exam (GRE) scores accepted but not required.

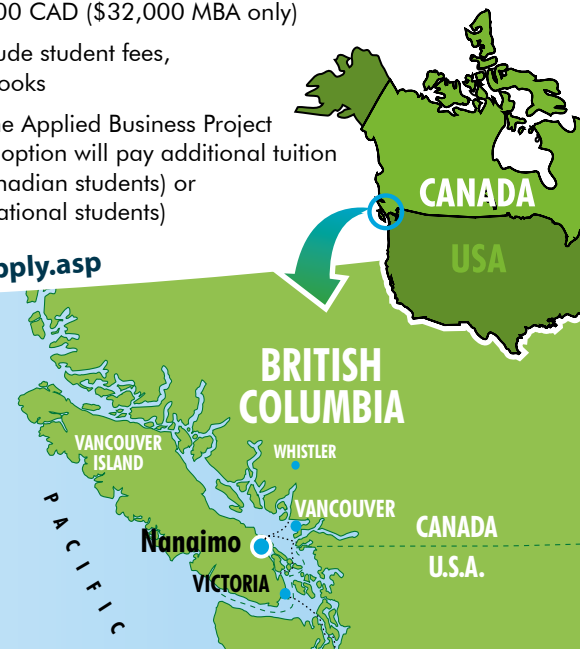
